

## VISHWAPRAKASH MISSION

## TERMS AND CONDITIONS FOR BENEFICIARIES – SCHOLARSHIP PROGRAMME

- 1. The applicants are selected as a beneficiary under the Scholarship programme based on their request, economic, social conditions and 12th standard marks.
- 2. Under Scholarship programme of Union Bank Social Foundation Trust (UBSFT) in association with Vishwa Prakash mission (VPM), the applicant seeks benefits for college purpose only.
- 3. The Scholarship programme will meet the educational expenses mainly the college fees, Hostel fees etc and no other expenses will be borne by the foundation.
- 4. Applicants will not seek benefits for Postgraduate courses/ degrees under the Scholarship programme.
- 5. UBSFT has the full rights to change the quantum of benefits etc. UBSFT and VPM do not entertain any recommendations, outside influence, money in the selection of the applicants.
- 6. If the selected beneficiary receives any form of financial assistance from the Govt/State or Central/Private institutions, the quantum of benefit may be changed and it has to be brought to the notice of the foundation.
- 7. No oral communication for benefits will be entertained. All benefits/ assistance will be directly payable to YMCA University
- 8. The beneficiaries will have to make their own arrangements for purchase of notebooks, transport fee, examination fee, security deposit etc.
- 9. The beneficiaries have to provide copies of fees paid receipts, exam results periodically, failing which future requests will not be entertained by UBSFT and/or VPM.
- 10. The mission, if necessary has full right to enquire about the conduct, study, progress of the beneficiaries from the participating educational institutions. In this regard the beneficiary or other persons connected with the beneficiary shall not have any right to interfere.
- 11. If the beneficiary has any pre existing ailments, diseases it is their duty to inform the mission. The foundation will not contribute for any medical assistance to the beneficiaries.
- 12. The beneficiaries and other connected persons of the beneficiaries should not in any way use the name of the mission or the participating educational institutions for wrongful means, purpose and self promotion.
- 13. The beneficiary should not discontinue their studies at any cost. The families, connected persons of the beneficiaries should not interfere in the studies of the students and they are not eligible for any benefit from the mission.
- 14. Beneficiaries during their study period should follow and abide by the terms and conditions set out by YMCA University, UBSFT and VPM. Further the beneficiaries' conduct, cooperation, marks obtained and the cooperation from their family will also be taken into consideration while considering continuation of/selection for scholarship

- 15. Beneficiaries during their period of studies should not indulge in unlawful activities, should not cause any harm/ damage to public properties, college, staff and students.UBSFT and VPM will not be having any responsibility, if any such thing happens.
- 16. Beneficiaries should not marry or initiate any activities of marriage during their study period. If it is known to the contrary they will be disqualified from the Scholarship Programme immediately.
- 17. Beneficiaries should observe decency with other beneficiaries. They should not interfere with other's rights.
- 18. Parents/guardians of the beneficiaries whenever called by UBSFT or VPM to inform about the complaints about their wards, if any, should personally attend for the same.
- 19. Beneficiaries should inform any changes in their address/contact numbers to Vishwa Prakash Mission/ College.
- 20. Beneficiaries should attend the training session/seminar if any arranged by UBSFT or VPM to improve their capabilities.
- 21. Beneficiaries have to inform their personal requests, grievances or complaints if any about staff of UBSFT or VPM to VPM only and not to outsiders.
- 22. Beneficiaries should abide by the rules and regulations framed by UBSFT and VPM from time to time. Beneficiary and his/her parents will have no objection in UBSFT, VPM publishing names, photos and result of the students assisted by the mission. The beneficiaries should abide and follow the above said rules and conditions without fail. If their conduct is not satisfactory they would be removed from the programme at any time and the financial assistance provided to them will also be stopped.
